#### ABSTRACT

This is the second seminar organized in order to provide a channel of communication and exchange between scholars and research students of both institutions. Our inaugural event celebrated the life and work of Mauro Cappelletti who served in both at Università di Firenze and EUI, and who carried out pathbreaking work in a number of legal fields. This year our focus shifts from the work of a single person to contemporary developments in the field of technology.

Technology is having an increased impact on the way we lead our lives: it is transforming social relations, accelerating the way information is transmitted, and increasing the volume of knowledge that is available to the public. It creates both opportunities and risks. In this one day conference we address some of the challenges that technology raises and how law responds. First we look at public power and the risk of it misusing technology. In this context we discuss state surveillance in the era of counter-terrorism, and the move towards e-Governance. Second, we consider how far private relations are reshaped, focusing on e-justice initiatives on the one hand and on the conceptualization of the notion of property in the virtual world.
