ENROLMENT/ATTENDANCE FEES TO BE PAID BY VISITING STUDENTS, IF ANY	Students are responsible for the cost of their accommodation (housing), food, and other expenses. They also have to pay university fees of approximately \$650.



INSURANCE INFORMATION (our students are covered by a mobility insurance)	BU requires all students to have health insurance that is equal to or better than the insurance offered by the university. Students can apply for a waiver of university insurance by showing that they are covered by their home institution's insurance plan that meets these standards.
HOUSING (available options, prices, etc.)	BU has limited university owned housing for graduate students, so must students rent apartments with others Housing is expensive in Boston, so students should plan to pay between \$800-\$1,500 per month. 	Once formally admitted to Miami Law's International Exchange Programs, students will receive additional information on the required documents to obtain an F-1 student visa, if necessary.

REQUIRED LANGUAGE SKILLS (accepted tests and level)	Waivers of the English-language proficiency test requirement may be granted in situations where the applicant can present other evidence of English language capability, such as a bachelor's degree or higher from an accredited institution in the U.S. or other English-speaking countries or from an accredited institution where courses are taught entirely in English.
ENROLMENT/ATTENDANCE FEES TO BE PAID BY VISITING STUDENTS, IF ANY	Exchange students will pay tuition to their home institutions, if applicable. They will not pay Miami Law tuition or mandatory fees, except for the Health Insurance fee and Counseling Center fee. The Counseling Center fee is approximately \$220/semester. Exchange students are required to pay this fee, and it is separate from the health insurance coverage. *Fees are subject to change annually
INSURANCE INFORMATION (our students are covered by a mobility insurance)	Exchange students must obtain health insurance for
	international students through UM. The health insurance cost for the Fall 2023 semester is \$1,500 (Coverage dates: 8/15/2023-1/04/24).

HOUSING (available options, prices, etc.)	J.D. programs at American universities are professional graduate-level programs. All graduate students attending UM, including the Law School, live off-campus. The Law School is located in Coral Gables, a residential area. Exchange students will be invited to participate in the Miami Law Housing and Living in Miami Online Session, prior to the semester start date. In this online

If we require additional details or documents to process your I-20 Form, we will contact you via email. Please keep in mind that receipt of an I-20 Form does not guarantee that a visa will be issued. The discretion to issue visas rests with the United States Department of State and U.S. consular offices abroad (https://www.state.gov/visas/).

	Students requiring a visa should monitor visa processing and appointment procedures for the U.S. consulate in your jurisdiction. Students entering the U.S. on an F-1 student visa may arrive no more than 30 days prior to the official program start date listed on their I-20 Form. In planning for their arrival, students should consider travel restrictions such as government-mandated travel restrictions or quarantines, and/or airline route cancellations.

As a reminder, UM is not liable for any related expenses students incur during travel planning. As such, we recommend that, when possible, students avoid financial commitments (i.e., booking travel) until closer to the start of the semester and after they have obtained any necessary travel visa.
